

**DIRECTIONS TO DISCIPLINARY BOARD OFFICE
TWO LEMOYNE DRIVE
LEMOYNE, PENNSYLVANIA**

Read through these directions before attempting to follow them.

From the North (I-81):

BRIEF DIRECTIONS:

I-81 to Front Street, Exit 66 [Old Exit 22]. South on Front Street.

Turn right over first bridge at Forster Street.

Cross bridge. Take second exit, Erford Road.

Bear right onto Erford Road at traffic light.

Straight on Erford Road to second traffic light. Continue straight onto Twelfth Street, which bends right.

At stop sign, turn right onto Lemoyne Drive.

Immediately turn left into driveway in front of black glass buildings and park in front of left building, labeled "Two."

DETAILED DIRECTIONS WITH LANDMARKS:

Take I-81 South to Exit 66 [Old Exit 22](Front Street). At the end of the off-ramp, bear left and go South on Front Street. Proceed approximately 2 1/2 miles south on Front Street until you reach Forster Street (the streets preceding Forster are Verbeke, Cumberland, Herr, and Boas). At Forster Street, turn right onto the North (M. Harvey Taylor) Bridge to the Camp Hill Bypass to the West Shore. This is the first bridge after I-81.

Take the Bypass over the North (Taylor) Bridge over the Susquehanna River to the West Shore. Pass the exits on the bank of the West Shore and proceed approximately 3/4 mile inland to the Erford Road exit.

Take the Erford Road Exit, wind around the cloverleaf, and turn right onto Erford Road. You will pass back over the highway you just left and proceed past the Pennsylvania Medical Society Building and the Harrisburg Academy on the left and the rear entrance to the Radisson Penn Harris Inn and Convention Center on the right. Proceed to the traffic light at Walnut Street, where a Texaco station is located. Go straight through the traffic light onto Twelfth Street. The street bends to the right and comes to a stop sign at an intersection with Lemoyne Drive. Turn right onto Lemoyne Drive, then left into the parking lot joining two black glass buildings with red trim. The Disciplinary Board is located in Building Two on the left. Drive around to the back of the building, park, and enter the main doors facing the embankment. The hearing office is on the second floor.

Lemoyne Drive is a very short stretch between Twelfth Street and the Radisson Penn Harris Inn and Convention Center. If you get lost, the easiest way to find the office is to ask for directions to the Radisson Penn Harris, then take Lemoyne Drive between the Fulton Bank and the McDonald's opposite the Radisson Penn Harris.

**DIRECTIONS TO DISCIPLINARY BOARD OFFICE

Read through these directions before attempting to follow them.

From the South (Pa. Turnpike, I-83):

BRIEF DIRECTIONS:

Pa. Turpike to Exit 242 [Old Exit 18], Harrisburg West.

North on I-83 to Rt. 581 (Camp Hill).

Rt. 581 to intersection with Rt. 11-15 at Camp Hill.

Rt. 11-15 North to split just beyond 21st St. traffic light; bear right onto Walnut Street. Right onto Lemoyne Drive between Fulton Bank and McDonald's.

Third right (after driveways to Fulton Bank and post office) on Lemoyne Drive into driveway between black glass buildings. Park and enter the building on the left, labeled "Two."

DETAILED DIRECTIONS WITH LANDMARKS:

From Philadelphia or east, take the Pennsylvania Turnpike to Exit 242, Harrisburg West. From the turnpike take I-83 North. At the Camp Hill Interchange (Exit 41A [Old Exit 20]), follow the signs toward Camp Hill (Rt. 11).

Take Rt. 11-15 west toward Camp Hill, Carlisle, and Gettysburg. Proceed to the Camp Hill Exit (first exit), and take Rt. 15 North toward Camp Hill. Proceed past numerous traffic lights at the Camp Hill Mall and Market Street. Rt. 15 then bends to the right (east). Get in the right lane prior to the major intersection at 21st Street, and proceed straight through the intersection. Most traffic will continue straight ahead onto the Camp Hill Bypass, but you must bear right as far as you can onto Walnut Street (Rt. 11-15), past the Dorado Restaurant toward the Radisson Penn Harris Inn and Convention Center. [If you miss Walnut Street and find yourself on the Camp Hill Bypass toward Harrisburg, follow the directions below].

Proceed on Walnut Street about 1/2 mile until you see the Camp Hill Post Office on the right and the Radisson Penn Harris Inn and Convention Center on the left. There is a Fulton Bank and a McDonald's on the right opposite the Radisson Penn Harris. Turn right on the road between Fulton Bank and McDonald's; this is Lemoyne Drive. Pass driveways for the Fulton Bank and the post office until you come to a driveway leading to two black glass buildings with red trim. Turn right into this driveway. The Disciplinary Board is located in Building Two on the left. Drive around to the back of the building, park, and enter the main doors facing the embankment. The hearing office is on the second floor.

If you pass Walnut Street and find yourself on the Camp Hill Bypass toward Harrisburg, turn off at the Erford Road Exit and turn right off the exit ramp. Proceed on Erford Road until you pass the rear entrance to the Radisson Penn Harris Inn and Convention Center and a Texaco Station on the right and the Harrisburg Academy on the left. Go straight through the traffic light onto Twelfth Street. This bends around to the right and comes to a stop sign at Lemoyne Drive. Turn right onto Lemoyne Drive and immediately left onto a driveway leading toward two black glass buildings with red trim. The Disciplinary Board is located in Building Two on the left. Drive around to the back of the building, park, and enter the main doors facing the embankment. The hearing office is on the second floor.

From the West (Pittsburgh, Pennsylvania Turnpike):

BRIEF DIRECTIONS:

Pennsylvania Turnpike to Exit 17, Gettysburg Pike.

Route 15 North through Camp Hill to split just past 21st Street traffic light. Bear right onto Walnut Street.

Right onto Lemoyne Drive on near side of McDonald's.

Third right on Lemoyne Drive into driveway between black glass buildings. Park and enter the building on the left, labeled "Two."

DETAILED DIRECTIONS WITH LANDMARKS:

From the west, take the Pennsylvania Turnpike to Exit 17 (Gettysburg Pike). Off the turnpike, take Route 15 North toward Camp Hill. Proceed north approximately 4 miles, going straight through numerous traffic lights at the Camp Hill Mall and Market Street. Rt. 15 then bends to the right (east). Get in the right lane prior to the major intersection at 21st Street, and proceed straight through the intersection. Most traffic will continue straight ahead onto the Camp Hill Bypass, but you must bear right as far as you can onto Walnut Street (Rt. 11-15), past the Ground Round Restaurant toward the Radisson Penn Harris Inn and Convention Center. [If you miss Walnut Street and find yourself on the Camp Hill Bypass toward Harrisburg, follow the directions below].

Proceed on Walnut Street about 1/2 mile until you see the Camp Hill Post Office on the right and the Radisson Penn Harris Inn and Convention Center on the left. There is a Fulton Bank and a McDonald's on the right opposite the Radisson Penn Harris. Turn right on the road between Fulton Bank and McDonald's; this is Lemoyne Drive. Pass driveways for the Fulton Bank and the post office until you come to a driveway leading to two black glass buildings with red trim. Turn right into this driveway. The Disciplinary Board is located in Building Two on the left. Drive around to the back of the building, park, and enter the main doors facing the embankment. The hearing office is on the second floor.

If you pass Walnut Street and find yourself on the Camp Hill Bypass toward Harrisburg, turn off at the Erford Road Exit and turn right off the exit ramp. From the Southwest (I-81):

BRIEF DIRECTIONS:

I-81 to Exit 19, Route 581

Route 581 to Rt. 11 in Mechanicsburg.

Route 11-15 North through Camp Hill to split just past 21st Street traffic light. Bear right onto Walnut Street.

Right onto Lemoyne Drive on near side of McDonald's.

Third right on Lemoyne Drive into driveway between black glass buildings. Park and enter the building on the left, labeled "Two."

DETAILED DIRECTIONS WITH LANDMARKS:

From the southwest, take I-81 to Exit 19 (Route 581). Rt. 581 feeds on to Route 11 near Mechanicsburg. At the Camp Hill Exit, take Rt. 11-15 North 15 North toward Camp Hill (Camp Hill Mall -- Boscov's visible just before this exit). Proceed north approximately 4 miles, going straight through numerous traffic lights at the Camp Hill Mall and Market Street. Rt. 15 then bends to the right (east). Get in the right lane prior to the major intersection at 21st Street, and proceed straight through the intersection. Most traffic will continue straight ahead onto the Camp Hill Bypass, but you must bear right as far as you can onto Walnut Street (Rt. 11-15), past the Ground Round Restaurant toward the Radisson Penn Harris Inn and Convention Center. [If you miss Walnut Street and find yourself on the Camp Hill Bypass toward Harrisburg, follow the directions below].

Proceed on Walnut Street about 1/2 mile until you see the Camp Hill Post Office on the right and the Radisson Penn Harris Inn and Convention Center on the left. There is a Fulton Bank and a McDonald's on the right opposite the Radisson Penn Harris. Turn right on the road between Fulton Bank and McDonald's; this is Lemoyne Drive. Pass driveways for the Fulton Bank and the post office until you come to a driveway leading to two black glass buildings with red trim. Turn right into this driveway. The Disciplinary Board is located in Building Two on the left. Drive around to the back of the building, park, and enter the main doors facing the embankment. The hearing office is on the second floor.
