**October 16, 2020 | Harrisburg, Pennsylvania**

Annually, the Disciplinary Board collects demographic data from Pennsylvania attorneys during the attorney registration process. During this year's annual attorney registration, attorneys were asked to provide voluntary responses to one question regarding gender and one question regarding race/ethnicity. The questions mirrored those utilized by the Unified Judicial System to collect and report employment data to the federal government.

Relative to gender, attorneys were provided with three options for response:

- *Male*
- *Female*
- *Prefer Not to Answer*

Relative to race/ethnicity, attorneys were provided with nine (9) options for response, with definitions provided as follows:

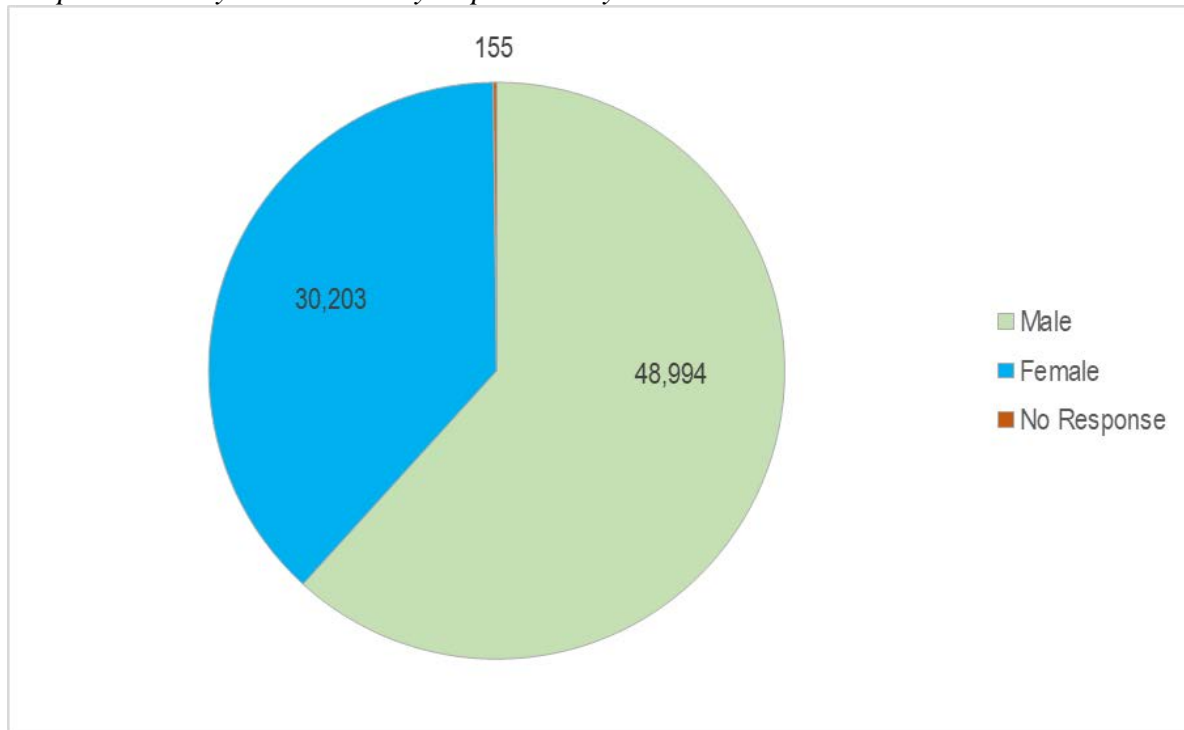
- *Hispanic/Latino*: A person of Cuban, Mexican, Puerto Rican, South or Central American, or other Spanish culture or origin regardless of race.
- *White (Not Hispanic or Latino)*: A person having origins in any of the original peoples of Europe, North Africa, or the Middle East.
- *Black/African American (Not Hispanic or Latino)*: A person having origins in any black racial groups of Africa.
- *Asian (Not Hispanic or Latino)*: A person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian Subcontinent, including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.
- *American Indian or Alaska Native (Not Hispanic or Latino)*: A person having origins in any of the original peoples of North and South American (including Central America), and who maintain tribal affiliation or community attachment.
- *Native Hawaiian or Other Pacific Islander (Not Hispanic or Latino)*: A person having origins in any of the peoples of Hawaii, Guam, Samoa, or other Pacific Islands.
- *Two or More Races*: All persons who identify with more than one of the above races.
- *Other*
- *Prefer Not to Answer*

The tables and graphs below are representative of the aggregate responses with respect to age, gender, and race and/or ethnicity for all attorney-registrants who provided responses to the questions, including those who do not maintain an office in Pennsylvania. These figures include attorneys who are registered as either Active (which includes the following statuses: Active, In-House Corporate Counsel, Temporary Licensee, and Foreign Legal Consultant) or Inactive. There exists slight variation in the total calculations for each chart because some attorneys did not respond to each question.

*Graph 2. Pennsylvania Attorney Population by Race/Ethnicity.*

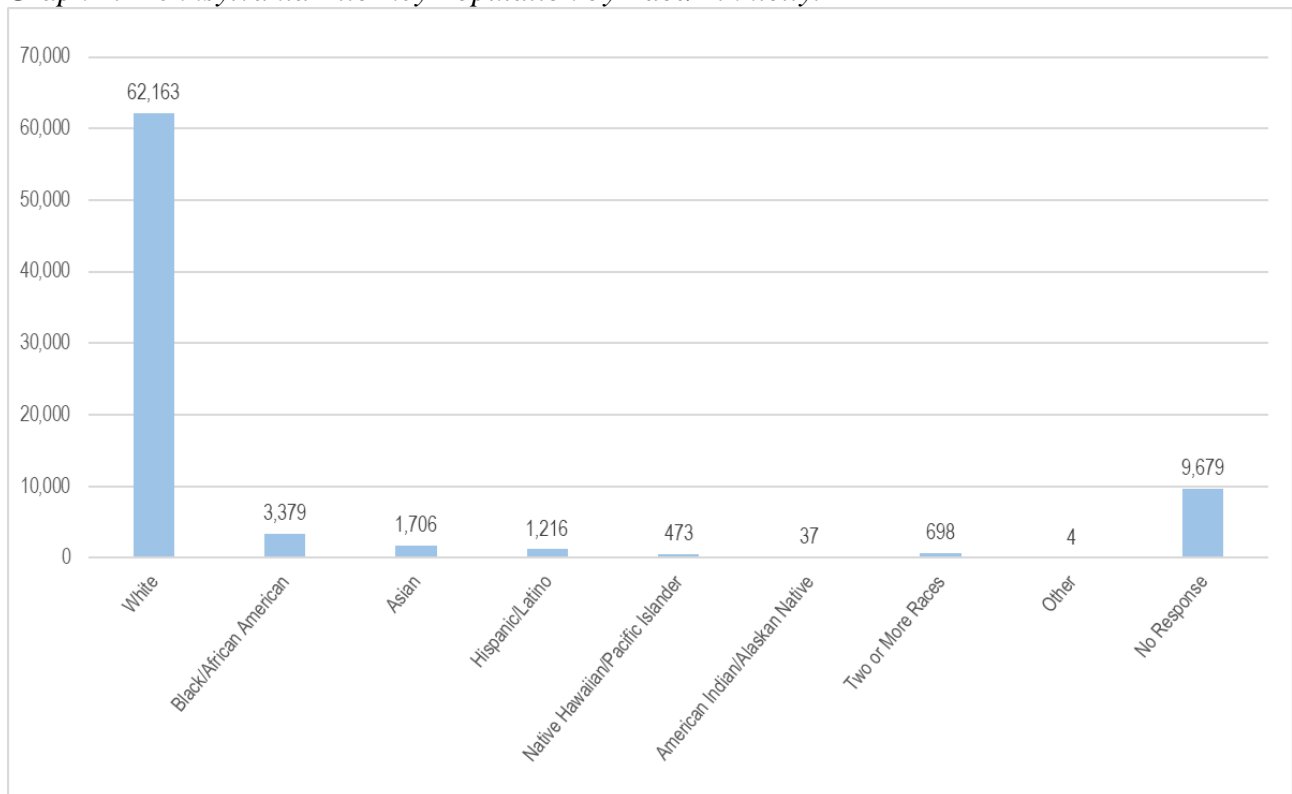
