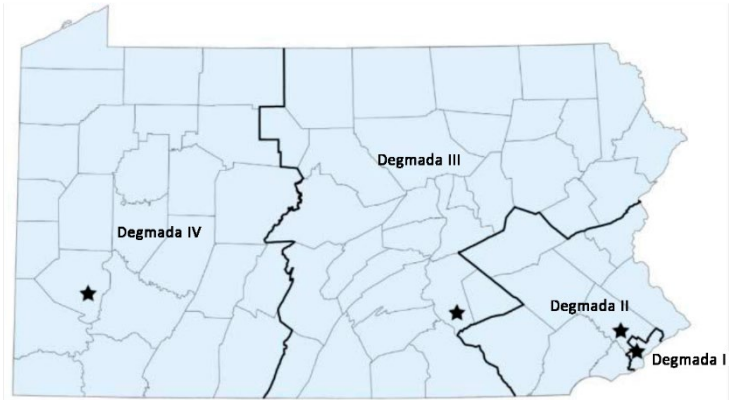
GUDBINTA DACWAD KA DHAN AH GARYAQAANKA

TILMAAMAHA:

Qoraal iyo bayaan saxeexan oo xaqiiqda ku saabsan waa in loo gudbiyaa Guddida Anshaxa ka hor inta aan la tixgelin cabashadaada. Sidaa darteed, sida ku cad *bayaanka cabashada*, fadlan si buuxda oo gebi ahaanba u qeex xaqiiqooyinka iyo duruufaha cabashadaada, oo ay ku jiraan taariikhaha la xiriira, xiriirada aad la sameysay qareenka, qabanqaabinta ujrada, taariikhda iyo qadarka la siiyay qareenka, adeegyada la qabanayo, magacyada iyo cinwaanada shakhsiyaadka kale ee ku lug leh arrinta sharciga, *sida saxda ah dhaqanka aad aaminsan tahay inuu yahay mid anshax xumo ama sharci darro ah*, iwm.
