I. Introduction

A. What Is the Case Research Collection?

The Case Research Collection (CRC) is an online database of the Disciplinary Board of the Supreme Court of Pennsylvania's past discipline, making available case information and documents. Entries from January 2016 through the present are included in the CRC. Users are welcome to browse the collection or to utilize a wide variety of search criteria to narrow findings.

B. What is available to users?

All entries in the CRC provide a basic set of information, including keywords, rule violations, and disposition. Differing documents are also available for each type of matter.

Private Discipline: For discipline matters resulting in a sanction of informal admonition or private reprimand, a summary of discipline is provided, but documents and identifying information remain confidential.

Public Discipline: For discipline matters resulting in a sanction of public reprimand, public censure, suspension, or disbarment, the CRC provides Board reports as well as Board and Supreme Court orders and opinions. When appropriate, a joint petition in support of discipline on consent may be provided in place of a Board report. Other confidential documents, including some resignation statements, are not publicly available and are not included in the CRC.

Reinstatements: In reinstatement matters, the CRC provides Board reports as well as Supreme Court orders and opinions.

II. Navigating the Search Form

A. General Search Criteria

Once logged into the CRC, users are able to search and browse case entries based on a variety of criteria. For digestibility, the search form has been broken into three main sections. The first section – “General Search” – is comprised of the following fields: first name, middle name, last name, and suffix. Users may also search cases by county and by accessibility (i.e. only public discipline, only private discipline, or both).

It is important to note that fields which would provide identifying information, including name and county, will not yield results for private discipline. Searching via keyword(s) may prove most useful in this situation. Searching via keyword(s) is detailed on page 4.

B. Searching by Rules

Below the “General Search,” users will find that they can also search cases by relevant rules. The first drop-down menu on the left allows users to choose from three sources of disciplinary authority: *The Rules of Professional Conduct* (R.P.C.), *The Pennsylvania Rules of Disciplinary Enforcement* (Pa.R.D.E.), and *The Disciplinary Board Rules and Procedures* (D. Bd. Rules). After selecting a rule book, users may choose a rule and paragraph, respectively, from the next two drop-down menus.

C. Searching by Keyword(s)

Users may also choose to search by a keyword or keywords. Click within the designated search bar to begin typing a keyword or to browse all available keywords. It is important to note that this search function will only respond to keywords from the dropdown menu. Users may begin typing a term as a means of locating a keyword more quickly, but users cannot insert their own keywords manually into the field. *Please see the appendix for a full list of searchable keywords.*



D. Additional Search Fields

To access additional search fields, click on “Search Additional Fields” found below the “Keywords” search bar (A). Additional fields include attorney registration number, case number, disposition type, decision and effective dates, and more (B). Searching for private discipline via attorney registration number will not yield results; searching via keyword(s) may prove most useful in this situation.


One common search in the “Disposition Description” field (B) is “On Consent”. This search will further narrow your results to cases in which a joint petition was granted by the Board or Court.

III. Viewing and Sorting Search Results

After selecting search criteria, click the blue “Search” button to view the results. Users are able to sort the results by the following: disposition date (newest first), disposition date (oldest first), last name (ascending), and last name (descending). Click on the blue “View Case” button to access further details of a particular case.

IV. Reading Case Entries

A. Overview of Case Details

A case entry is comprised of a variety of informative details. Due to the varying natures of CRC cases, not all data fields will be complete for every case. However, every public case entry will include the respondent's name, registration number, and county, as well as the case number, disposition, date of decision, effective date, and disciplinary counsel. Every private case entry will include the case number, disposition, date of decision, and effective date. Other details may include rule violations, relevant keywords, and more. 

V. Editing Search Criteria vs. Starting a New Search


To return to the search results, click the prompt in the upper left-hand corner (A). Once returned to the results list, a user may choose to continue browsing via the chosen criteria or may wish to view results under different criteria. There are two options for selecting new criteria (B). The “Edit Search Criteria” feature uses the existing criteria as a starting point and allows the user to remove one criterion at a time or to add a new one. If the user plans to search for cases using entirely new criteria, “Start a New Search” is a quicker way of doing so.
