By Order of the Supreme Court dated March 20, 2023, William E. Gericke was suspended on consent from the Bar of this Commonwealth for a period of one year.

PER CURIAM

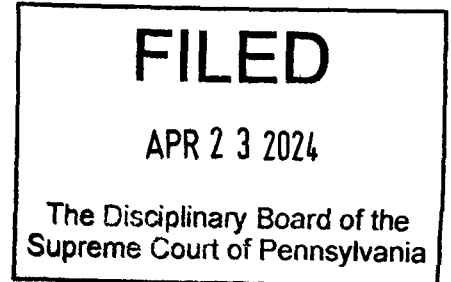
